



## **PUBLIC APPOINTMENTS TO BOARDS, COMMITTEES AND CORPORATIONS**

### **Beautification Committee**

The role of the Beautification Committee is to make recommendations for the development and implementation of strategies and plans for community beautification initiatives. The Beautification Committee aims to showcase community pride through ongoing initiatives fueled by public engagement and business sponsorships. The Committee will focus on first impressions whether it be for tourists, new residents and new businesses that are either considering to establish or simply visiting. The Committee will be comprised of two members of Council, 2 to 4 members of the public, one staff resource person while establishing partnerships with the Kapuskasing Horticultural Society, Green TK, service clubs and businesses. The resource staff person is the Recreation Director.

**(BIA) Business Improvement Area Board** of Management is comprised of six members, four elected by the Downtown Merchants Association and two Councillors. The BIA meets four times per year. The business improvement area covers the following areas, Circle, Queen Street from the Circle to Dallyn Avenue, Cain Avenue from Riverside Drive to the Circle and as far as the old Bucovetsky's, McPherson from the Circle to Riverside Drive and Byng Avenue from Riverside Drive to Queen Street. The BIA levy requisition was for \$30,000 which is raised from within the BIA based on share of business levy and funds are utilized for improvement projects and for promotion of the area. The resource staff persons are the CAO and the Clerk.

**Kapusksasing and District Planning Board** is comprised of seven members, two Councillors, four citizen members and one provincial appointee. The Board meets four times per year. The Board is responsible to advise Council on planning matters such as official plan and zoning by-law amendments. The Board resource staff person is the Chief Building Official.

**Kapusksasing Municipal Non-Profit Housing Corporation** is administered by the Housing Services department of the Cochrane District Social Services Administration Board and is comprised of seven members, six citizens and one Councillor. The Corporation meets 10 times per year. The Corporation oversees the Grandvue Seniors Building at 32 McPherson Avenue.

**Kapusksasing Police Services Board** will soon change to representation from the municipalities of Opasatika, Val Rita-Harty, Moonbeam, Fauquier-Strickland and Kapuskasing, including two provincially appointed members and two community appointed members in Kapuskasing. The new board composition will be in place in 2023. The municipality has a policing services contract with the Ontario Provincial Police and the 2022 budget is \$2,052,223. The resource persons are the CAO, General Manager of Protective Services and the Clerk, as the Board Secretary.

**Kapuskasing Public Library Board** Council has agreed that the composition of the Board be reduced to five members, three citizens and two Councillors. The Board meets 10 times per year. The Library mission statement is to provide a comfortable and enjoyable learning atmosphere for all members of the Kapuskasing community. The municipality contributed \$142,800 to the Library operations, pays the cost of liability insurance, building maintenance and utilities which amount to a budgeted amount of \$36,290 for 2022.

### **Senior's Advisory Committee**

The advisory committee will provide recommendations and advice to Council on matters which have a direct or indirect impact on seniors in the community. The committee will be responsible for matters such as helping to identify needs of seniors, potential opportunities on initiatives and/or projects to promote healthy senior lifestyle, identify barriers and overcome barriers for seniors, promote awareness and education, support partnerships and funding opportunities. The committee is to be comprised of two members of Council, 2 to 4 members representing seniors and one staff resource person.

### **Youth Advisory Committee**

The advisory committee will provide recommendations and advice to Council on matters which have a direct or indirect impact on youth in the community. The committee will be responsible for matters such as helping to identify needs of youth, potential opportunities on initiatives and/or projects to promote youth engagement, identify barriers and overcome barriers for youth, support partnerships and funding opportunities. The committee is to be comprised of two members of Council, 2 to 4 members representing youth from each high school and one staff resource person.

### **Citizen Advisory Committee**

The Citizen Advisory Committee will provide recommendations and advice to Council on matters which have a direct or indirect impact on community well-being which includes diversity, inclusion, equality, welcoming newcomers and civic pride. The Committee will be responsible for matters such as helping to identify needs of the community, potential opportunities and partnerships, including funding opportunities to promote civic pride, identify barriers and enhance the community's first impression and citizen engagement in the community. The committee is to be comprised of two members of Council, and 2 to 4 citizens of Kapuskasing.

The Senior's, Youth and Citizen Advisory Committees can work as one committee of Council to provide recommendations.

**Sports Palace Bar Operating Committee** is comprised of one council member, nine members of community and the resource staff is Marc Clavelle. The committee oversees the operation of the bar under the Sports Palace liquor permit.
